*Canadian Personal Tax Returns**

'The Essentials' Starting at **\$100 CAD** + HST

- Canadian Wages (T4)
- CPP/OAS Income (T4AP, T4AOAS)
- Unemployment benefits (T4E)
- Pension Income (Canadian – T4A)
- Union Dues
- Workman's Compensation (T5007)
- Social Assistance (T5007)
- Education Expenses (T2202A, TL11A, Student loan interest)

'The Common Folk' Starting at **\$200 CAD** + HST

'The Essentials', plus

- Investment Income/expenses (T3/T5 slip)
- Capital Gains Distributions (T3/T5 slip)
- US Social Security Income
- RRSP contribution/transfer/income
- HBP/LLP/FTHBC
- Child Care expenses
- Foreign Income/deductions/credit (T3/T5 slips only)
- Medical Expenses (no travel)
- Disability amount/transfer (no attending care expenses)

'The Sophisticated' Starting at **\$300 CAD** + HST

'The Common Folk', plus

- Pension Income Splitting (Pensioner Only)
- Capital Gains/Losses (on T5008 only)
- Foreign Income/deductions/credits (not on T3/T5 slips)
- Caregiver amount/infirm dependent/family caregiver
- Capital loss carry-forward/carry-back
- Medical Expenses (with travel)
- Moving expenses
- Disability amount/transfer (if attendant care expenses)
- Clergy deduction
- Partnership income/losses (Form T5013)

‘The Equalizer’ Starting at **\$500 CAD** + HST

‘The Sophisticated’, plus

- Capital gains/losses (up to 10 items if no T5008 slip/ACB)
- Business/Professional Income/Deductions (one T2125)
- Disposition of business/rental/farm property
- Rental Income/deductions (T776–up to 2)
- Capital Gains Deduction
- Employee Stock Compensation
- Employment Expenses
- AMT Carryovers
- GST 370 (Rebate)

Other Items/Returns

- Additional Business (T2125) /Rental (T776) - \$200 CAD each
- Part-Year (Immigration/Emigration)/Non-Resident return - \$250 CAD
- Forms T1135 (completed worksheet required – time charges apply for cost calculations – starting at \$250 CAD)
- Form T1134 – starting at \$750 CAD/return
- Voluntary Disclosures Program (VDP) – starting at \$1,250 CAD
- Section 216 (Non-Resident Rental) - \$750 CAD
- Section 217 (Non-Resident refund on certain types of income) - \$500 CAD
- T2062/T2062A Certificate of Compliance - \$750 CAD each
